It is therefore requested kindly to transmit the above instructions of the Competent Authority/Chairman BISE/Commissioner Lahore Division Lahore & worthy Secretary to Government of the Punjab, Higher Education Department to all lower formations in general and to the Resident Inspectors/Heads of Institutions in particular to adhere to the instructions in true letter and spirit and provide befitting protection through their chowkidars/security guards to the BISE materials and CCTV Cameras along with all paraphernalia so that any adverse action may not be affected against any of them please.
