#### Subject: MEASURES FOR SSC/ HSSC 1st (ANNUAL) EXAMINATION, 2025

I am directed to refer to the subject captioned above and state that SSC and HSSC, 1st Annual Examinations, 2025, are expected to commence from **04**th **March and 29**th **April, 2025**, respectively.

- 2. For efficient and smooth conduct of forthcoming SSC/HSSC, 1<sup>st</sup>Annual Examinations, 2025, by all the Boards in Punjab, following measures are required to be taken immediately:
  - i. An Examination Monitoring Cell has been established in the Higher Education Department, to monitor the SSC/ HSSC,1st Annual Examinations, 2025. This Cell will submit daily situation reports to the Chief Minister Punjab, Minister for Higher Education, Chief Secretary, Punjab& Secretary, Higher Education Department. All the Chairpersons, Boards of Intermediate & Secondary Education in Punjab will forward daily situation reports of both morning & afternoon papers to the Monitoring Cell through whatsapp on 0332-8343552 and email address <a href="mailto:soboards@gmail.com">soboards@gmail.com</a>, <a href="mailto:dsboards.hed@gmail.com">dsboards.hed@gmail.com</a>. Any direction issued by the Monitoring Cell shall be taken seriously and all possible efforts shall be made to implement such directions.
- ii. Special Squads for monitoring at district level shall be constituted by the respective Chairpersons of the Boards. One male and one female member will be appointed in special squads in each district. The squads shall submit their inspection reports on daily basis to the Chairperson of the concerned Board by endorsing a copy of the same to the Convener, Examination Monitoring Cell. The male and female members of the squads shall inspect male & female examination centres respectively in their districts.
- Chairpersons Boards will take all measures for smooth conduct of examinations.
- iv. Chairpersons Boards will ensure that the infrastructure, especially condition of all examination centres is satisfactory.

- v. All Chairpersons / Controllers of Examinations will remain present in the jurisdiction of their Boards during the conduct of HSSC 1<sup>st</sup> (Annual) Examinations, 2025. They will not leave their respective jurisdiction without getting prior permission in writing. During examination days, one of the officers of the Board, Chairperson / Secretary / Controller will remain present on the board's premises for immediate action on the directions of the Monitoring Cell and complaints received from field.
- vi. At the end of examination, Chairpersons will submit a report regarding number of visits made by the Chairperson /Controller /Secretary of the Board and members Special Squads, directions received from the Monitoring Cell and complaints from field and their addressal.
- vii. All Chairperson Boards will ensure that qualified and best supervisory staff will be deputed and list of staff will be provided to the concerned Director of Education (Colleges), and Chief Executive Officers of District Education Authorities before the commencement of examinations under intimation to the Higher Education Department and the concerned DPI.
- viii. All Directors of Education (Colleges), and Chief Executive Officers of District Education Authorities will ensure the availability of all supervisory staff deputed by the Boards. Absence of supervisory staff in examination / marking centres would be viewed seriously and will be proceeded under disciplinary rules.
- ix. It has been observed that during the conduct of Board's Examinations, proper co-operation and assistance is not extended by the Heads of Institutions in terms of provisions of building, furniture and human resources required for the said purpose. All heads of the Government educational institutions are required to co-cooperate and extend full support to the Board of Intermediate and Secondary Education in the conduct of examinations. Any violation of these instructions would be viewed seriously. Resident Inspector will ensure their presence at the examination centres till completion of the examinations.
- x. Chairpersons Boards will hold a meeting with the Directors of Education (Colleges), Chief Executive Officers of District Education Authorities and members of Special Squads for necessary instructions/availability of supervisory staff/date sheet/center building statements/infrastructure.
- xi. Chairpersons Board will establish District Control Rooms and notify Committees in consultation with Deputy Commissioners and DPOs. Notifications of such Committees will also be sent to the Monitoring Cell. Chairpersons Boards will hold a meeting with Committees to evolve plan for smooth conduct of examination. Chairpersons Boards will also ensure media coverage with reference to the measures taken by the Board/Government.

- xii. Chairperson Boards will also request, in writing, the Deputy Commissioner /District Administrator in their jurisdiction for imposition of Section 144 around the centres.
- xiii. Chairpersons Boards will provide lists of building notices to District Police Officers in their jurisdiction for deployment of Police contingents.
- xiv. Chairpersons Boards will send the list of hard/sensitive centres and special days to the Deputy Commissioners and DPOs for special arrangements.
- xv. Chairpersons Boards will send a list of "Ghunda Elements" and "Booti Mafias" likely to be involved in SSC/ HSSC, 1stAnnual Examinations, 2025 to the Deputy Commissioners/DPOs before the commencement of examination.
- xvi. All Directors of Education (Colleges) and CEOs in Punjab are requested to endorse the above instructions to all Heads of Educational Institutions in their jurisdiction.
- xvii. Examination centers will be established in public sector buildings having large capacity and an approachable / convenient access. To this effect, public colleges, schools, universities will be accorded priority. As a policy, large halls should be preferred, instead of scattered countless small rooms to ensure reduction in number of examination centers as far as possible, in order to ensure cost & resource efficiency and better supervision. Whereas, notorious examination centers will be scrapped / blacklisted.
- xviii. As highlighted by Boards, in case there is no other option than to select private colleges / schools as examination center, due to non-availability of suitable public / rented private halls in the area, the decision to select a private institution as exam center will be ratified by BOG of the respective BISE, on case to case basis.
- xix. Each Board will undertake a rigorous exercise to purge its Conduct Branch off all the unscrupulous elements. Scrutiny of the personnel serving in Conduct Branch will be conducted through Special Branch.
- xx. Installation of cameras in examination halls for coverage of the examination will be ensured by BISEs.
- xxi. There will be complete ban on hiring of private invigilators, in any case; staffing shall be ensured through SED / HED only. In case of any emergent situation, respective Resident Inspector, Deputy Director (Colleges) & CEO (Education) shall be jointly responsible to ensure suitable replacement. In this regard, HED & SED will issue instructions for compliance by the said officers.
- xxii. To attract dedicated HR for supervisory duty, each BISE will enhance remuneration packages. All Boards will pay Rs.1800 for single duty and Rs. 2500 for double duty.
- xxiii. Board will scrutinize lists of supervisory staff on the basis of



their previous record. Soon after, the Board will refer the particulars of Supervisory Staff to Special Branch for clearance. Permanent blacklisting of the staff not cleared in scrutiny will be ensured.

- xxiv. In order to ward off any possible collusion / nexus, BISEs shall ensure random shuffling of supervisory staff after every 02 days. The shuffling will be within a tehsil but not in the previous Union Council. Moreover, the shuffling will be individual based, and not team based.
- xxv. Each BISE will forward a reference against the absconders and delinquent employees of HED / SED to initiate disciplinary proceedings against them.
- xxvi. Role of Resident Inspectors / Head of the institutes will be reemphasized and reinvigorated. Instead of their merelyceremonial presence, which too was found missing in many cases during SSC exam, 2024, the Institute heads / RIs and Mobile Inspectors shall also be held responsible for any untoward incident, misappropriation or malpractice at their respective Centre.
- xxvii. To ensure the Secrecy of Examination Papers, printing of the QR code / uniquely identifiable water-mark on each question paper will be ensured.
- xxviii. Zero-tolerance policy will be implemented in case of any premature leakage of question paper on Social media or otherwise. FIRs / disciplinary action against respective center in-charge/ whole team & administrators of social media groups/ web pages will be taken.
- 4. It is desired that necessary action may be taken on priority basis and compliance report to this effect may be sent to the Higher Education Department.

POOR RESPONSE REGARDING AVAILABILITY OF HUMAN RESOURCE FOR CONDUCT OF UP-COMING SSC/HSSC,1stANNUAL EXAMINATIONS, 2025

I am directed to refer to the subject and to state that HSSC and SSC 1st Annual Examinations, 2025, are scheduled to commencing from <u>04th March</u>, 2025 and 29th April, 2025, respectively.

- 2. This department solicits your kind support to steer this important exercise towards successful accomplishment of the same in public interest. To this effect, it is imperative that the bottlenecks and barriers, previously observed on the road to befitting accomplishment, be addressed / redressed proactively. For example, poor response is received from the teachers who have shown interest in appointment as supervisory staff, i.e., Superintendents, Deputy Superintendents & Invigilators. Especially, availability of invigilators at female centres is a cause of concern. Furthermore, it has been observed that most of the deputed invigilators do not report for duty at the assigned centres, leaving the Superintendents to arrange the invigilating staff at the earliest hour, which creates a lot of problems during examinations.
- 3. Following are the main causes of response from the staff deputed for examination duty:-
- District Administration/Head of Institution does not allow the teachers to perform examination duty due to the fear of poor performance of their Districts.
- Marking of teachers as absent by the DMOs during inspection of Schools.
- DEAs/Deputy DEAs& Heads of institutions hesitate to allow the teachers to perform examination duty due to fear of poor performance.
- I am, therefore, directed to request your good-self to kindly issue necessary instructions to all the Chief Executive Officers of District Education Authorities in Punjab and Directors to ensure availability of teachers for assigned duties of examination so that the forthcoming SSC / HSSC, 1st Annual Examinations, 2025, may be conducted smoothly.

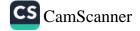
