This refers to our earlier communications on the subject noted above.

1. Under the auspices of Board of Intermediate and Secondary Education, Lahore, the Secondary School Certificate (1st Annual) Examination, 2025, is going to commence w.e.f. March 04, 2025 within its territorial jurisdiction.
