REGISTRATION & MAKING OF IMPERSONATION, UMC & STRAY CASES IN THE EXAMINATIONS 2025 AND ONWARDS IN FUTURE ALL EXAMINATIONS.

Apropos the Registration of an impersonation case at Manawala District Sheikhupura on the subject noted above.

- 2. I am directed by the Competent Authority/Commissioner Lahore/Chairman BISE, Lahore to convey the following instructions for strict compliance in true letter and spirit in the ongoing examinations and in all the examinations to come in future too to be conducted by the BISE, Lahore.
- (a) The impersonation, UMC & stray cases must be got registered after due diligence, proper investigation, tangible and credible evidences, undeniable facts and merit of the subject cases.
- (b) Any wrong registration of the above cases may ruin the academic and future lives of candidates so affected in such cases hence utmost care is required.
- (c) Such cases need to be thoroughly probed into by keeping in view the photographs of the candidates, their credentials, home address, phone number, parentage, admission form to be retrieved from the BISE tabulation branch and the confessional statement (written or verbal) of the candidates in case of registration of such cases so that there must not be any wrong registration or making of such cases at all.
- (d) Registration of an FIR or UMC and Stray cases are serious matters that need to be investigated with proper wisdom, diligence and foresight before action.

It is therefore requested kindly to be very watchful and meticulous in such cases to save the academic lives and social fabric of original candidates. All are required to adhere to the above instructions in true letter and spirit.

Apropos the subject noted above.

- 2. I am directed by the Competent Authority/the worthy Chairman BISE, Lahore/Commissioner, Lahore to inform that the following instructions must be adhered to in true letter and spirit regarding the registration of UMC, Impersonation cases/FIRs and Stray Cases against the candidates appearing for SSC & HSSC Examination 2024 and in all examinations to come in future too so that no innocent candidate is involved in such cases without proper investigation, collection of evidences, statements of all concerned, proper cross examination on spot with thorough verification, re-verification and counter checking of all relevant record available on spot and in BISE.
- 3. I am further directed to convey that if any UMC, Impersonation case & FIR or Stray cases are made against the candidates where the candidate is innocent and have nothing to do with above matters, the Superintendent concerned being the custodian of the Examination Centre and launcher of the FIR against the candidates and in such cases SHALL PERSONALLY BE HELD RESPONSIBLE and any appropriate punitive action may be taken and recommended against such superintendent that may lead to suspension, imposition of PEEDA ACT 2006 or permanent or partial disqualification from all BISE duties.
- 4. It is therefore reiterated to be very careful and meticulous in such cases to avoid any kind of embarrassment to the Superintendent or the candidates please. The above instructions MUST BE ADHERED TO IN TRUE LETTER AND SPIRET.
