ELIGIBILITY/QUALIFICATION CRITERION:

Internet Service Providers (ISPs) who meet the following criteria are only eligible to apply:

- 1- The bidder should be in the business of ISP from minimum last 7 years and must have contract with at least five organizations (minimum Bandwidth of 50 Mbps each). The bidder should enclose the list of such offices along with P.O.
- 2- The bidder should be Government Organization or a private limited Company.
- 3- The bidder should have acquired valid ISP License and has established Fiber and Wireless/RF network.
- 4- The ISP should have a fully functional customer service centre with 24x7x365 help desk covering the location of Lahore.
- 5- Local peering, within Pakistan, with multiple ISPs.
- 6- Attach details of litigation or arbitrations or black-listing if any, if none as affidavit of no arbitration and of never having been black-listed to be submitted.
- 7- ISP should have direct peering with Tier-1 carriers to minimize the number of hops and latency to international destinations. Details of Tier-1 carriers with which peering is done are to be provided.
- 8- The ISP should have fully resilient and self-healing network architecture, on fiber medium, for the domestic backbone up to the international gateway in Pakistan.
