NOTIFICATION

DISSEMINATION & SHARING OF QUESTION PAPERS (OBJECTIVE/SUBJECTIVE) ON SOCIAL MEDIA

According to Sections 3.a(iv) and 3.a(xii) of the Punjab University and Boards of Intermediate & Secondary Education Malpractices Act 1950, as amended in 1999, the following penalties can be imposed in case the question papers are posted/circulated/shown on Social Media before or after the conduct of examination: See the text of the Act:

Whoever is guilty of:

"Pre-mature disclosure of a question or question paper knowing that such question or question paper is to be put or set at any examination written or oral, shall be punished with imprisonment for a term which may extend to 3 years and with fine which may extent to Rs.50,000/-."

- 2. Furthermore, during the examination, no person shall take a picture of the question paper with the use of any device/gadget/mobile, make any sort of recording and shall not impede the examination process in any manner since it is illegal and prohibited to do so. In such a situation, under the provisions 3.a(vi), 3.a(x) and 3.a(xii) of the said Act, the punishment can be three (3) years imprisonment and a fine of fifty thousand rupees.
- 3. No unauthorized person shall enter in any Examination Centre and Practical Laboratory, otherwise, an FIR shall be got registered against such illegal entrants.
- 4. Mobile phones or any such other restricted devices are strictly banned in Examination Centres and Practical Labs as the presence of such devices shall entail permanent disqualification and action under the relevant provisions of PEEDA ACT 2006.
- 5. In the light of the above rules, all concerned are requested not to indulge in the use of any illegal means in the examinations organized by the BISE, Lahore otherwise, disciplinary action shall be taken as per the rules. All the concerned are further requested kindly to transmit the information to General public and all officers/officials concerned for strict compliance in true letter and spirit.
